INTRODUCTION

Professor Whish will review the recent case-law of the Competition Appeal Tribunal in the UK and the European Community Courts in Luxembourg. In particular he will discuss:

- the meaning of the terms 'agreement' and 'concerted practice', which the Competition Appeal Tribunal has considered in several cases
- the distinction between agreements that have as their 'object' the restriction of competition and agreements that have the 'effect' of doing so
- the treatment of joint selling arrangements
- the position of third party complainants in competition proceedings
- various procedural issues such as privilege against self-incrimination and the Courts' attitude towards fines

ABOUT THE SPEAKER

Richard Whish is Professor of Law at Kings College, London where he has worked since 1991. His professional career has been devoted to competition law and policy, and he has written extensively on competition law matters.

He was in practice, as a partner at Watson, Farley and Williams, with responsibility for the Competition Law practice, from 1989 to 1998. He continues to act as a consultant to many clients on competition law. He has clients in a wide variety of sectors, including energy, financial and legal services, chemicals, telecommunications, the media and postal services.

He has also extensive experience of advising and/or providing training to Governments and NGOs on the development of competition law. For example, he has worked on the development of Competition Law in Jamaica, Guyana, Vietnam, Malta, Hungary, Poland, Slovenia, South Africa, Hong Kong, Zambia and Egypt.

He has been a non-executive director of the Office of Fair Trading, UK, since April 2003.
